1 **RESOLUTION 3-01A**

2 **To Affirm the Biblical Teaching of Sexuality, Marriage, and Family**

3 Overture 3-01 [CW, p. 33]

4
5 WHEREAS, "God created man in His own image, in the image of God He created him; male and female He
6 created them" (Gen.1:27), which is the foundational truth for all teaching about Sexuality,
7 Marriage, and Family (Matt. 19:4-6); and
8

9 WHEREAS, the earthly relationship between husband and wife is to be a reflection of Christ's relationship to
10 His bride, the Church (Gen. 2:18-25; Eph. 5:21-33); and
11

12 WHEREAS, God's gift of sex is to be used only within the marriage covenant between one man and one
13 women for the purposes of creating new human life where God wills (Gen. 1:27-28), celebrating
14 the unconditional love, and commitment between husband and wife (Song of Songs; Matt. 19:4-6)
15 and the restraining of lust (1 Cor. 7:9); and
16

17 WHEREAS, Holy Scripture is clear that all sexual activity outside of the marriage covenant (e.g., fornication,
18 adultery, sexual co-habitation, polygamy, pornography, pedophilia, prostitution, same-sex
19 intercourse, and all sexual lust) is condemned by God (Lev. 18 & 20; Matt. 19:4-12; Rom. 1:26-
20 32; 1 Cor. 6; 1 Thess. 4:1-8); and

22 WHEREAS, the Holy Scriptures teach us that Christ Jesus has borne all the sins of the body upon Himself so
23 that the Church might proclaim the compassionate and forgiving Lord to all who struggle with
24 every sin of the body and mind, and bear witness by her actions of the Lord's grace and mercy;
25 and

27 WHEREAS, there are organizations (e.g. PFLAG, QSA, GLAAD, and many others), that proclaim a false
28 message of acceptance of sin, while not providing true comfort and correction for the sinner; and
29

30 WHEREAS, these organizations have sought and received acceptance and support in education campuses even
31 within the LCMS; therefore, be it
32

33 RESOLVED that the South Wisconsin District assembled in Convention, June 10-12, 2018, boldly confess the
34 biblical position of proclaiming the Law to unrepentant sinners and the Gospel to all sinners who
35 do repent; and be it further
36

37 RESOLVED, that all congregations, schools, universities, and seminaries in the LCMS be encouraged to be
38 faithful in their care for all sinners, never condoning intentionally or unintentionally any sexual
39 sins, but rather providing conversation, comfort, and sound biblical encouragement to all who
40 struggle with sexual sins; and finally, be it
41

42 RESOLVED, that all pastors, churches, schools, and university within the South Wisconsin District encourage
43 all Christians to pray for and work faithfully with those struggling with homosexual and all other
44 sinful sexual desires, according to apostolic exhortation: "Brethren, if a man is overtaken in any
45 trespass, you who are spiritual restore such a one in a spirit of gentleness, considering yourself lest
46 you also be tempted. Bear one another's burdens, and so fulfill the law of Christ" (Galatians 6:1-2)
47 and "Do you not know that the unrighteous will not inherit the kingdom of God? Do not be
48 deceived. Neither fornicators, nor idolaters, nor adulterers, nor homosexuals, nor sodomites, nor
49 thieves, nor covetous, nor drunkards, nor revilers, nor extortioners will inherit the kingdom of
50 God. And such were some of you. But you were washed, but you were sanctified, but you were
51 justified in the name of the Lord Jesus and by the Spirit of our God" (1 Corinthians 6:9-11).
